4. The work for which nomination is made must have been carried out in India (except for Overseas Fellow award).
5. Each nomination must be proposed and seconded by two persons, out of whom at least one should be Fellow or Life member of SBBS.
6. The criteria for the awards are performance based on publications/impact factors/citations/patents/technology transfers, etc. However, for certain categories of awards, due consideration will be given to the nominees for their contribution for the growth of the SBBS.
